ORDER GRANTING REINSTATEMENT OF LICENSE

On March 6, 2020, in Case No. H-3247 FR a Decision was rendered revoking the
real estate broker license of Respondent effective April 27, 2020, but granting Respondent the
right to the issuance of a restricted real estate broker license. A restricted real estate broker
license was issued to Respondent on April 27, 2020, and Respondent has held a restricted license
since that time.

On May 18 18, 2022, Respondent petitioned for reinstatement of Respondent's real estate broker license, and the Attorney General of the State of California has been given notice of the filing of the petition.

I have considered Respondent's petition and the evidence submitted in support thereof. Respondent has demonstrated to my satisfaction that Respondent meets the requirements of law for the issuance to Respondent of an unrestricted real estate broker license and that it would not be against the public interest to issue said license to Respondent.
