8	and the Regulations as set forth in the following paragraphs, and as more fully discussed in
9	Audit Report LA200042 and the exhibits and workpapers attached to said audit report.

11	Respondent FORBIX accepted or received funds in trust ("trust funds").
12	Thereafter, Respondent made deposits and or disbursements of such trust funds. During the
13	examination period described in Paragraph 7 above, Respondent deposited or maintained trust
14	funds in the following bank accounts:
15	Trust Account 1: City National Bank account ending in 867.

18	In the course of activities described in Paragraph 6 above and during the
19	examination period described in Paragraph 7 above, Respondent FORBIX acted in violation of
20	the Code and the Regulations in that:

2	SUPERVISION AND COMPLIANCE
3	11.
4	The conduct, acts, or omissions of Respondent KHODORKOVSKY, as
5	described in Paragraphs 9 and 10 above, in failing to ensure compliance of the Real Estate Law
6	by Respondent FORBIX, is in violation of Code section 10159.2 and Regulations 2725, and
7	subjects all the licenses, license endorsements, and license rights of KHODORKOVSKY to
8	suspension or revocation pursuant to Code sections 10177(d), 10177(g), and 10177(h).
9	12.
10	Code section 10148(b) provides, in pertinent part, that the Real Estate
11	Commissioner shall charge a real estate broker for the cost of any audit if the Commissioner has
12	found in a final decision, following a disciplinary hearing, that the broker has violated Code
13	section 10145 or a Regulation or rule of the Commissioner interpreting said Code section.
14	13.
15	Code Section 10106 provides, in pertinent part, that in any order issued in
16	resolution of a disciplinary proceeding before the Department of Real Estate, the Commissioner
17	may request the administrative law judge to direct a licensee found to have committed a
18	violation of this part to pay a sum not to exceed the reasonable costs of the investigation and
19	enforcement of the case.
