16	On June 5, 2017, in Case No. H-12007 SF, a Decision was rendered revoking the
17	real estate broker and real estate corporation licenses of Respondents effective July 3, 2017, but
18	granting Respondents the right to the issuance of a restricted real estate broker license and a
19	restricted real estate corporation license. A restricted real estate broker license and a restricted
20	real estate corporation license were issued to Respondents on July 3, 2017, and Respondents
21	have held restricted licenses since that time.
22	On September 16, 2019, Respondents petitioned for reinstatement of
23	Respondents' real estate broker and real estate corporation licenses, and the Attorney General of
24	the State of California has been given notice of the filing of the petition.
25	I have considered Respondents' petition and the evidence submitted in support
26	thereof. Respondents have demonstrated to my satisfaction that Respondents meets the
27	requirements of law for the issuance to Respondents of an unrestricted real estate broker license

1	and an unrestricted real estate corporation license, and that it would not be against the public	
2	interest to issue said licenses to Respondents.	
3	NOW, THEREFORE, IT IS ORDERED that Respondents' petition for	
4	reinstatement is granted and that real estate broker and real estate corporation licenses be issued	
5	to Respondents if Respondents satisfy the following requirements:	
6	1. Submit a completed application and pay the fee for a real estate broker	
7	license and a real estate corporation license within the 12 month period following the date of this	
8	Order; and	
9	2. Submit proof that Respondent JASON DAVID CROUCH has completed	
10	the continuing education requirements for renewal of the license sought. The continuing	
11	education courses must be completed either (i) within the 12 month period preceding the filing of	
12	the completed application, or (ii) within the 12 month period following the date of this Order.	
13	This Order shall become effective immediately.
