1 TERMS AND CONDITIONS 2 Respondent understands that the Real Estate Commissioner ("Commissioner") may hold a hearing regarding the matters discussed above for the purpose of requiring further proof of 3 Respondent's honesty and truthfulness and to prove other allegations therein, or that the 4 Commissioner may waive the hearing and grant Respondent a restricted real estate salesperson 5 license based upon this Stipulation and Waiver. Respondent also understands that by entering into 6 this Stipulation and Waiver, Respondent will be stipulating that the Commissioner has found that 7 Respondent has failed to make a showing that Respondent meets all the requirements for issuance 8 of a real estate salesperson license thereby justifying the denial of the issuance to her of an 9 unrestricted real estate salesperson license. 10 11 Respondent hereby admits the above Factual Basis is true and correct and requests that the Commissioner issue a restricted real estate salesperson license to Respondent under the 12 authority of section 10100.4 and 10156.5 of the Code. Respondent understands that any such 13 restricted license will be issued subject to the provisions of and limitations of sections 10156.6 and 14 15 10156.7 of the Code. Respondent understands that by signing this Stipulation and Waiver, provided this 16 Stipulation and Waiver is accepted and signed by the Commissioner, the Commissioner will not 17 file a Statement of Issues based on the grounds herein, and Respondent is waiving his right to a 18 hearing and the opportunity to present evidence at the hearing to establish her rehabilitation in 19 order to obtain an unrestricted real estate salesperson license. Respondent is not waiving his right to 20 a hearing and to further proceedings to obtain a restricted or unrestricted license if this Stipulation 21 and Waiver is not accepted by the Commissioner. 22 Respondent agrees that by signing this Stipulation and Waiver, the conditions, 23 limitations, and restrictions imposed on Respondent's restricted salesperson license, identified below, may 24 25 be removed only by filing a Petition for Removal of Restrictions ("Petition") with the Commissioner, and that Respondent's Petition must follow the procedures set forth in Government Code Section 11522. 26 Respondent understands that this Stipulation and Waiver, which was executed pursuant to 27

Respondent further understands that the restricted salesperson license issued to
 Respondent shall be subject to all of the provisions of Section 10156.7 of the Code and to the
 following limitations, conditions, and restrictions imposed under the authority of Section 10156.6
 of the Code:

The restricted salesperson license shall not confer any property right in the
privileges to be exercised and the Commissioner may by appropriate order suspend the right to
exercise any privileges granted under this restricted license in the event of:

a. Respondent's conviction (including a plea of nolo contendere) of a
 crime which bears a substantial relationship to Respondent's fitness or capacity as a real estate
 licensee; or

b. The receipt of evidence that Respondent has violated provisions of
 the California Real Estate Law, the Subdivided Lands Law, Regulations of the Commissioner, or
 conditions attaching to this restricted license.

Respondent shall not be eligible to petition for the issuance of an unrestricted
 real estate license nor the removal of any of the conditions, limitations, or restrictions attaching to
 the restricted real estate salesperson license until two (2) years have elapsed from the date of issuance
 of the restricted real estate license to Respondent. Respondent shall not be eligible to apply for any
 unrestricted licenses until all restrictions attaching to the license have been removed.

3. With the application for license, or with the application for transfer to a new
 employing broker, Respondent shall submit a statement signed by the prospective employing broker
 on a form approved by the Department wherein the employing broker shall certify as follows:

a. That broker has read the Stipulation and Waiver which is the basis for
 the issuance of the restricted license; and

b. That broker will carefully review all transaction documents prepared
by the restricted licensee and otherwise exercise close supervision over the licensee's performance
of acts for which a license is required.

arrest by sending a certified letter to the Commissioner at the Department of Real Estate, Post
Office Box 137007, Sacramento, CA 95813-7007. The letter shall set forth the date of
Respondent's arrest, the crime for which Respondent was arrested and the name and address of the
arresting law enforcement agency. Respondent's failure to timely file written notice shall constitute
an independent violation of the terms of the restricted license and shall be grounds for the
suspension or revocation of that license.
