

ORDER TO DESIST AND REFRAIN

The Real Estate Commissioner of the State of California has caused an investigation to be made of your activities as a real estate broker, and based on the findings of that investigation is of the opinion that THE LOAN CORPORATION and RON JOHN LECLAIR, individually and as designated officer of The Loan Corporation, have violated Sections 10235, 10235.5, 10236.4, 14701, 17539.4 of the Business and Professions Code (hereinafter "Code") as well as Sections 2847.3 and 2848 subdivisions (4) and (5) of Chapter 6, Title 10, California Code of Regulations (hereinafter "Regulations").

At all times mentioned herein, you, THE LOAN

CORPORATION, were licensed by the Department of Real Estate of
the State of California (hereinafter "Department") as a corporate
real estate broker with Respondent RON JOHN LECLAIR as the
designated officer.

2.

At all times mentioned herein, you, RON JOHN LECLAIR, individually and as designated officer of The Loan Corporation, were licensed by the Department as a real estate broker.

3.

You, THE LOAN CORPORATION and RON JOHN LECLAIR, knowingly advertised, printed, displayed, published, distributed, or caused or permitted to be advertised, printed, displayed, published, or distributed, statements or representations with regard to the rates, terms, or conditions for making, purchasing, or negotiating loans on real property which were false, misleading, or deceptive.

4.

Your conduct, as alleged in Paragraph 3, above, is in violation of Code Section 10235 and Section 2848 subdivisions (4) and (5) of the Regulations.

5.

You, THE LOAN CORPORATION and RON JOHN LECLAIR, included the name, trade name, logo, or tagline, of a lender in solicitation for financial services directed to a consumer who has obtained a loan from the lender without the consent of the

lender, and which failed clearly and conspicuously to state that you are not sponsored by or affiliated with the lender and that the solicitation is not authorized by the lender, which shall be identified by name. This statement shall be made in close proximity to, and in the same or larger font size as, the first and most prominent use or uses of the name, trade name, logo, or tagline in the solicitation.

6.

Your conduct, as alleged in Paragraph 5, above, is in violation of Code Section 14701.

7.

You, THE LOAN CORPORATION and RON JOHN LECLAIR, placed one or more advertisements disseminated primarily in the State of California for the making or arranging of a loan, including a solicitation for borrowers or potential investors, that failed to disclose within the printed text of the advertisement, or the oral text in the case of a radio or television advertisement, a complete identification of the license and license number under which the loan would be made or arranged and the state regulatory entity supervising that type of loan transaction.

Your conduct, as alleged in Paragraph 7, above, is in violation of Code Sections 10235.5, 10236.4, 17539.4 and Section 2847.3 of the Regulations.
