DECISION

This Decision is being issued in accordance with the provisions of Section 11520 of the Government Code, on evidence of compliance with Section 11505 of the Government Code and pursuant to the Order of Default filed on May 27, 2011, and the findings of fact set forth herein are based on one or more of the following: (1) Respondent's express admissions; (2) affidavits; and (3) other evidence.

The right to reinstatement of a revoked license is controlled by Section 11522 of the Government Code. A copy of the Commissioner's <u>Criteria of Rehabilitation</u> is attached hereto for the information of the Respondent.

FINDINGS OF FACT

I

On July 28, 2008, Robin L. Trujillo made the Accusation in her official capacity as a Deputy Real Estate Commissioner of the State of California. The Accusation, Statement to Respondent, and Notice of Defense were mailed, by certified mail, to Respondent's last known mailing address on file with the Department on August 13, 2008.

On May 27, 2011, no Notice of Defense having been filed herein within the time prescribed by Section 11506 of the Government Code, Respondent's default was entered herein.

ΙI

Respondent's license expired on September 8, 2008. The Department retains jurisdiction pursuant to Business and Professions Code ("Code") Section 10103.

III

On or about January 2, 2007, the Franchise Tax Board of the State of California, suspended the powers, rights and privileges of Respondent pursuant to the provisions of the California Revenue and Taxation Code.

IV

Respondent's powers, rights and privileges remain suspended.

DETERMINATION OF ISSUES

I

Cause for disciplinary action against Respondent exists pursuant to Section $\underline{2742}$ of Title 10, Chapter 6, California Code of Regulations, and subjects its real estate license and license rights to suspension and revocation pursuant to Business and Professions Code Sections $\underline{10177(d)}$ and $\underline{(f)}$.

II

The standard of proof applied was clear and convincing proof to a reasonable certainty.

ORDER

The license and license rights of Respondent GREAT WESTERN LENDING GROUP, INC. under the provisions of Part I of Division 4 of the Business and Professions Code are revoked.

The conduct of Respondent, GREAT WESTERN LENDING GROUP, INC., as alleged above, was in violation of Section 2742 of Title 10, Chapter 6, California Code of Regulations, and subjects its real estate license and license rights to suspension or revocation pursuant to Sections 10177(d) and (f) of the Code.
