ORDER GRANTING REMOVAL OF DISCIPLINE INFORMATION FROM RESPONDENT'S

ORDER GRANTING REINSTATEMENT OF LICENSE

On March 22, 2011, in Case No. H-36274 LA, a Decision was rendered revoking all licenses and license rights of Respondents, effective April 13, 2011. On April 25, 2021, Respondent MIKE REZA AHMARI was granted reinstatement of his real estate broker license.

1. Submit a completed application and pay the fee for a corporate real estate broker license.
2. Designate MIKE REZA AHMARI as the broker-officer for the corporation.
