Respondent's failure to report the conviction alleged in Paragraph 3, above, to the Department in writing within 30 days of the conviction as required by the provisions of Code Section 10186.2(a)(1)(B) and 10186.2(a)(2) constitutes grounds under Code Section 10186.2(b) to suspend or revoke Respondent's license and license rights pursuant to Code Sections 10177(d) and/or 10177(g).
