I hereby request that the Commissioner in his discretion issue a restricted real estate salesperson license to me under the authority of Sections 10100.4 and 10156.5 of the Code. I 2 understand that any such restricted license will be issued subject to the provisions and limitations of 3 Sections 10156.6 and 10156.7 of the Code.

I understand that by my signing of this Stipulation and Waiver, provided this Stipulation 5 6 and Waiver is accepted and signed by the Commissioner, the Commissioner will not file a Statement of Issues based on the grounds herein, and I am waiving my right to a hearing and the 7 opportunity to present evidence at the hearing to establish my rehabilitation in order to obtain an 8 unrestricted real estate salesperson license. 9

I agree that by signing this Stipulation and Waiver, the conditions, limitations, and 10 restrictions imposed on my restricted license, identified below, may be removed only by filing a 11 Petition for Removal of Restrictions ("Petition") with the Commissioner, and that my Petition must 12 follow the procedures set forth in Government Code Section 11522. 13 14 I further understand that the restricted license issued to me shall be subject to all of the provisions of Section 10156.7 of the Code and to the following limitations, conditions and 15

restrictions imposed under authority of Section 10156.6 of the Code: 16

1. The restricted license shall not confer any property right in the privileges to be exercised including the right of renewal, and the Commissioner may by appropriate order suspend the right to exercise any privileges granted under the restricted license in the event of:
