1 On or about October 4, 1993, in the Circuit Court of Orange County, Florida, Case 3. 2 No. CR 93-5261, Respondent was convicted on a plea of nolo contendere to violation of Florida Statute 893.13(1)(a)(1) (delivery of cocaine), a felony in the second degree. The court sentenced 3 Respondent to 1 day time served in the Orange County Jail, followed by one year of probation 4 5 with conditions, and ordered Respondent to pay costs and fees. On or about February 13, 1995, in the Circuit Court of Orange County, Florida, 6 4. Case No. CR 94-11444, Respondent was convicted on a plea of nolo contendere to violation of 7 Florida Statute 893.13(1)(a) (possession of cannabis with intent to sell), a felony in the third 8 degree. Respondent's failure to disclose the convictions, as set forth in Paragraphs 2 through 4 above, in his license application constitutes an attempt to procure a real estate license by 27 fraud, misrepresentation, or deceit, or by making a material misstatement of fact in an application, 28
